#### **Exciting Updates and Transitions!**

he UC Davis Retiree Center was created to serve UC Davis retirees and to support the work of the associations — the UC Davis Emeriti Association (UCDEA) and the UC Davis Retirees' Association (UCDRA). Founded in 2006 the Retiree Center celebrated a tenth anniversary last year and we have a great deal of news to share in this current year.

#### New relationships and benefits

First, the Retiree Center has been, and continues to be, a unit of the Development and Alumni Relations department on campus. In the spring of 2016 the administration of the Retiree Center transitioned to the Alumni Relations unit (also under Development and Alumni Relations) and in early 2017 interim director Becky Heard was named as director of the Retiree Center.

The alignment of the Center as a unit of the Cal Aggie Alumni Association (CAAA) means additional benefits and values are available to retirees. First, retirees can participate in CAAA Aggie Adventures Travel, a world-class travel program providing Aggies with exciting group travel opportunities. Additionally, members of the UCDRA and UCDEA are eligible to access CAAA partner discounts such as PetersenDean's "Solar 4 America" program offering a 5% discount off a solar system, new roof or energy storage nationwide. Affiliates 50 years and older, military veterans, and first responders also receive an additional \$500 off. Other benefits and discounts available to UCDRA/UCDEA and CAAA members include insurance programs through Mercer (numerous insurance plans are available at a discount including, health, dental, major medical, disability, long term care

As a distinguished scholar and accomplished administrator, Dean Spiller has a deep understanding of the history of the liberal arts and sciences and their place at the heart of the modern research university. She has been assigned to return the College back to a single-dean model. Dean Spiller will share her vision for the College at the Retiree fall meeting

A professor of English, Spiller came to UC Davis from the College of Liberal Arts and Human Sciences at Virginia Tech where she oversaw 12 academic departments and programs. She received a Bachelor of Arts in English at Amherst

College, and a Master of Arts and Ph.D. in English and American language and literature at Harvard University. She specializes in early modern literature and culture, with emphasis on the history of reading, and on literature and science.

As part of the Fall Retiree Meeting, Guerren Solbach will present a short summary of healthcare changes in coverage and the major impacts of the upcoming Open Enrollment. #### **Parking for HCF Program Presentations**

Permit parking in B lots is on a "first come-first served" basis. Retiree (RT) permits are eligible to park in any B lot. Parking in the structure adjacent to the main hospital is available on the lower level, level 1, level 2 or level 3 in the ungated area at \$2/hr. Parking in Parking Structure #2 adjacent to the Ellison Ambulatory Care Bldg., 4860 Y Street, is allowed on the 2<sup>nd</sup> floor or higher. Daily parking for \$6 is available in Lots 14, 16, 18, and 25. Shuttle service is available. # Calls for Distinguished Emeritus/a and Panunzio Awards

all brings the call for nominations for two prestigious emeriti awards, both of which are administered by the UCDEA.

#### UC Davis Distinguished Emeritus/a Award

The Distinguished Emeritus/a Award honors outstanding scholarly work or service (*e.g.*, service in professional, university, Academic Senate, emeriti/ae, or departmental editorial posts or committees) performed since retirement by a UC Davis emeritus/a in any discipline.

The recipient will be recognized at the Emeriti and Academic Retirees luncheon in 2018, and will receive a plaque and a cash award of \$1,000.

The deadline to apply for this award is October 30, 2017

## Constantine Panunzio Distinguished Emeriti Award

The Constantine Panunzio Emeriti Award is a UC system-wide award that honors outstanding scholarly work or educational service (e.g., service in professional, university, Academic Senate or departmental editorial posts or committees) performed since retirement by a University of California emeritus or emerita in the humanities or social sciences.

The award is announced in April of each year and the recipient(s) will receive a \$5,000 prize.

The deadline to apply for this award is November 16, 2017.

#### **Nomination Process**

Nominations for both awards should be submitted to the UCDEA Awards and Recognition Committee. Emeriti/ae may nominate themselves or colleagues. Nomination packets must include:

 a cover letter outlining the nominee's distinctive scholarly work or service since retirement
