Important Retiree Health Benefit Update

Health Net Seniority Plus to be replaced in 2020

Retirees who currently have Seniority Plus and who do not make another choice during Open Enrollment will be automatically enrolled in a new United Healthcare Medicare Advantage PPO. The new plan, called UC Medicare Choice, will offer similar coverage but with access to more doctors for a lower premium.

During this year's Open Enrollment (Oct. 31- Nov. 26, 2019), retirees eligible for Medicare and UC retiree health coverage will have the option to enroll in UC Medicare Choice or in any of UC's other Medicare plans — UC Medicare PPO or UC High Option Supplement to Medicare plans or Kaiser Permanente Senior Advantage.

Parking in Parking Structure #2 adjacent to the Ellison Ambulatory Care Building, 4860 Y Street, is allowed on the 2nd floor or higher.

My personal tribute to all of them, and to all the other emeriti who have passed away this past year, and condolences to their families and friends.

I would like to thank Jo Anne Boorkman for stepping up to provide invaluable support as I unexpectedly assumed the UCDEA President position following Tom Sallee's passing. I am most grateful for her support.

Calls for Distinguished Emeritus/a and Panunzio Awards

Fall brings the call for nominations for two prestigious emeriti awards, both administered by the UCDEA.

UC Davis Distinguished Emeritus/a Award

The Distinguished Emeritus/a Award honors outstanding scholarly work or service (**e.g.**, service in professional, university, Academic Senate, emeriti/ae, or departmental editorial posts or committees) performed since retirement by a UC Davis emeritus/a in any discipline.

The recipient will be recognized at the Emeriti and Academic Retirees luncheon in 2019, and will receive a plaque and a cash award of \$1,000.

The deadline is **November 1, 2019**.

Constantine Panunzio Distinguished Emeriti Award

The Constantine Panunzio Emeriti Award is a UC systemwide award that honors outstanding scholarly work or educational service (**e.g.**, service in professional, university, Academic Senate or departmental editorial posts or committees) performed since retirement by a University of California emeritus/a in the humanities or social sciences.

The award is announced in April of each year and the recipient(s) will receive a \$5,000 prize.

The deadline to apply is **November 1, 2019**.

Nomination Process

Nominations for both awards should be submitted to the UCDEA Awards Committee. Emeriti/ae may nominate themselves or colleagues. Nomination packets must include:

- cover letter outlining the nominee's distinctive scholarly work or service
- a curriculum vitae listing accomplishments since retirement
- the names of three to five references who could write supporting letters (Panunzio Award only)

Laky named Dickson Professorship Award Winner

The Edward A. Dickson Emeriti Professorship Award is an endowed fund that provides support to emeriti/ae professors for their teaching, research, and/or public service. Separate endowments support these professorships at each UC campus and the award is administered separately on each campus.

The UC Davis Emeriti Association announces that Gyöngy Laky was awarded the 2019-2020 Edward A. Dickson Professorship Award to advance her project, "Preparing for the Unexpected: The Life and Art of Gyöngy Laky", a book about her life and her art.

Laky has been an artist for over 50 years and taught 28 years as a professor at UC Davis. She chaired the Department of Art at UC Davis in the mid-1990's, and led efforts in gender equity and diversity in faculty hiring post-Proposition 209 for the UC system. The Emeriti Association is pleased to support her project and looks forward to its success.
